DEAN OF THE SCHOOL OF POSTGRADUATE STUDIES DIPONEGORO UNIVERSITY,

- Considering : a. that based on Article 2 paragraph (1) of the Government Regulation of the Republic of Indonesia Number 52 of 2015 concerning the Statute of Diponegoro University, Undip has a vision to become an Excellent Research University;
- b. that based on the analysis of needs in improving understanding and ability in the implementation of learning systems and transforming, developing, and disseminating science, technology, and art through education, research, and community service at the international level, the Master and Doctoral Study Program in Environmental Science needs to appoint a Team for Strengthening the Activities of Lecturers at the International Level who are experts in their fields;
- c. that based on the considerations referred to in letter a and letter b, it is necessary to determine the Decree of the Dean of the School of Postgraduate Studies Diponegoro University concerning the Appointment of a Team for Strengthening Lecturer Activities at the International Level in the Master and Doctoral Study Program in Environmental Science School of Postgraduate Studies Diponegoro University in 2022;
