- Considering :
- a. that based on Article 69 paragraph (1) of the Government Regulation of the Republic of Indonesia Number 52 of 2015 concerning the Statute of Diponegoro University, to carry out the improvement of leadership, reasoning, interests, passions, and improvement efforts student welfare in student life formed student organizations;
 - b. that based on the analysis of needs to accommodate the aspirations of students as well as a forum for student affairs, the Doctoral Study Program in Environmental Sciences, School of Postgraduate Studies Diponegoro University raised those who were considered capable and meet the qualifications to carry out the duties of a Student Association Administrator;
 - c. that based on the considerations referred to in letter a and letter b, it is necessary to determine the Decree of the Dean of the Postgraduate School of Diponegoro University concerning the Appointment of the Management of the Student Association of the Doctoral Study Program in Environmental Sciences Diponegoro University Graduate School in 2022.

FOURTH: This decision is valid from January 3, 2022 to December 31, 2023.
